Hybrid proceedings

From Monday 8 June the House will move to a hybrid model meaning Members can participate in proceedings both virtually and, to a very limited degree, physically in the Chamber. The Procedure Committee has updated its guidance to reflect these changes but below is the information you will require to sign up to speak.

As per the Procedure Committee guidance, Members will need to continue signing up in advance to take part in most items of business, including oral questions. Members will be able to add their names to speakers' lists in the usual way.

To allow social distancing in the Chamber only a small number of Members will be able to take part physically, there are around 30 spaces but this includes the frontbenches, the Clerk and the Deputy Speaker on the Woolsack.

Each party/group will continue to order their own speakers with the Government Whips' Office ordering the smaller groups and non-affiliated Members.

In light of the current public health advice and the limited capacity in the Chamber it will be assumed that Members will continue to take part in proceedings virtually unless they indicate otherwise. If, after signing up to speak, Members wish to try and take part in a proceeding from the Chamber, they should email holgovernmentwhips@parliament.uk copying in their own Whips'/Convenor's office. If there are more Members wishing to take part physically than there are spaces in the Chamber it will be for each individual party/group to determine which of their Members make the final speakers' list.

To assist in ensuring the broadcasters receive accurate lists of those speaking we would ask that if Members intend to withdraw from a debate or oral question that they do so in good time. If a Member no longer wishes to speak in a debate or question please let us know by 11am the day before it is due to take place. This is extremely important for oversubscribed debates as it may allow another Member to take part.

- The number of sessions shown for a stage of a bill represents the Government's assessment of reasonable time given the balance of bills and remaining days to the likely end of the session. Progress remains in the hands of the House. Report stage is usually half the length of Committee
